General

1. By participating in the Broadsheet x G Adventures competition (Promotion), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
3. The Promotion commences at 18:00 (AEST) on Wednesday 10 October 2018 and closes at 18:00 (AEST) on Friday 14 December 2018 (Promotion Period).
4. Entry is open to Australian residents only who are over 18 years of age.

How to Enter
